Cape York Region Package Taskforce

March 2018

The Cape York Region Package (CYRP) Taskforce met on the 11th of December 2017 in Cairns, welcoming the attendance by the Hon Warren Entsch MP, Member for Leichhardt.

The last Taskforce meeting was held in Coen in July 2017, with the Sub Working Group meeting held in May 2017. Both groups continue to support and provide input and feedback to the Cape York Region Package (CYRP) into its final phase of delivery, and promote the need for further funding to complete sealing of the Peninsula Developmental Road (PDR) in a reasonable timeframe. The \$260.5M CYRP package is due for completion by June 2019, with the final works packages on the PDR to commence construction in 2018.

The Department of Transport and Main Roads (TMR) provided an **update of progress** on delivery of 2016 PDR projects, now all at practical completion, and the status of the four **2017 PDR projects**. Refer to tables below.

Design work has been completed for three 2018 PDR projects, with tenders to be released in 2018 for:

- Telecom Tower to Archer River 6.7km
- Piccaninny Black Soil 5.6km (tender released 2 February 2018)
- Fairview West (part A) 6.4km

Interest was expressed in tracking PDR project specific expenditure to date, whereby TMR advised overall project allocations are outlined in QTRIP and, should any savings be realised, they would be reinvested in further PDR upgrades. The key message from TMR is **the remaining approved program of PDR projects are on track for delivery by June 2019,** noting also the strong performance of contractors to date in achieving the Key Result Areas relating to Indigenous and Non-Indigenous training and employment, building Indigenous business capability and local industry participation.

The CIMA (Cape Indigenous Mayors Alliance – now established as the Torres Cape Indigenous Councils Alliance – TCICA) program of works in Cape communities is also well progressed. A number of **community infrastructure projects** have been completed under budget and ahead of schedule, with Federal and State Government approval obtained to reinvest savings in other priority Indigenous community infrastructure. Detailed updates are provided below.

Other matters discussed:

- The importance of building a CYRP business case demonstrating the significant economic and wider benefits of the current CYRP to inform efforts to secure further funding were discussed to:
 - complete the seal of the PDR to Weipa, and
 - progressively seal sections of Telegraph Road (PDR/ Northern Peninsula Road turn-off to Seisia)
- The Hon Warren Entsch MP, reiterated his support for future investment to deliver this critical
 economic and socially-enabling infrastructure to the Cape for the benefit of Cape and Torres
 communities and the regional economy.

- Cross-agency and stakeholder group support and interest was expressed in taking forward the
 development of a West Cape York economic strategy or blueprint to maximize the opportunities
 presented by the sealing of the PDR and manage impacts from increased tourism and other traffic.
- Maintenance of the PDR was a key issue with significant deterioration in some areas of the road
 impacting on locals, business, industry and tourists which flagged the broader issue of sufficiency
 of funding for road maintenance in the long-term, and further reinforced the benefits of fully
 sealing the PDR.
- In relation to the PDR Indigenous Land Use Agreement (ILUA), the Cape York Land Council and TMR noted the regular, positive and productive meetings of the ILUA Project Committee in resolving any emerging issues and tracking progress of delivering the Indigenous Economic Opportunities Plan.
- The non-government Taskforce members **supported the revised Terms of Reference and CYRP** for the Taskforce and the Sub-Working Group which will now be considered by the CYRP Board (the government agency governance mechanism).
